Dr. Etherton graduated from the University of Illinois with a masters' degree in cognitive-experimental psychology, and from the University of Georgia with a Ph.D. in clinical psychology. He has been a licensed psychologist since 2000, and board certified in clinical psychology in 2021 by the American Board of Professional Psychology (ABPP).



**Chris Funk**, Manager of Claims, Love's Travel Stops & Country Stores After graduating from Oklahoma State University with a Master's degree, he began his employment with Love's Travel Stops & Country Stores, Inc in December of 2009. 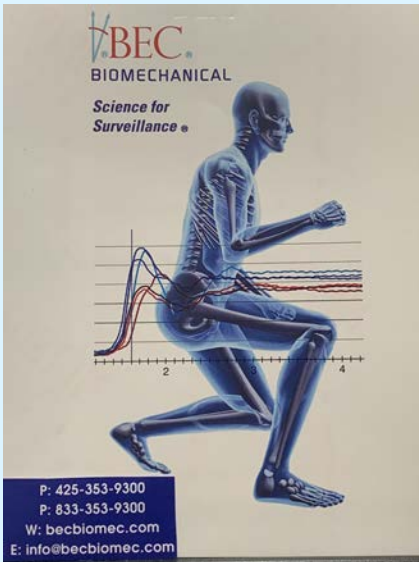
