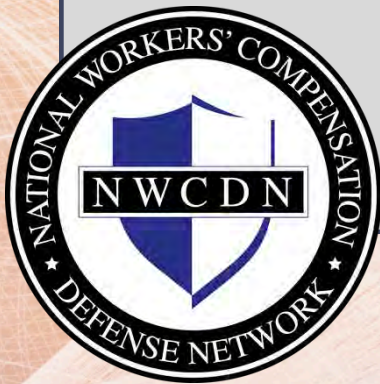
The National Workers' Compensation Defense Network is pleased to present the agenda for the upcoming Regional Conference.
